Safeguarding your water supply with Sampling, Testing and ongoing Water Monitoring

The build-up of limescale and biofilm is common within water systems and is something that can be easily avoided. If not regularly reviewed and inspected, this build-up can increase the risk of bacterial contamination at your premises. If not monitored and tested, bacteria in water systems can go unnoticed for long periods of time.

To effectively identify the presence of any dangerous bacteria in your water systems, water sampling and testing should be carried out regularly by industry professionals and processed by a UKAS Quality Assured Laboratory.

To ensure your business is compliant with legionella regulations in line with the HSE's Approved Code of Practice L8 and HSG 274 we recommend the implementation of a reliable Sampling, Testing and Water Monitoring regime.

Our process involves micro-bacterial analysis, water sampling, monitoring and the regular review of your water infrastructure in line with your business needs. 
Installing and servicing Chemical Dosing Systems


